Football: **Ready for change**

Coach says recruiting key to next year

hy would a former NFL and Division 1 Rose Bowl champion coach come to Alva to lead the NWOSU Rangers football team?

"There's nothing more than I would love to do than bring my alma mater back to its winning ways," said NWOSU head football Coach Ronnie Jones, during an interview with news reporting students on Friday.

Jones has had stints in the NFL with teams such as the Philadelphia Eagles and Arizona Cardinals. He won the Rose Bowl with the Arizona State Sun Devils.

He has coached at the pinnacle of sports, but he chose to come to his alma mater for his last years coaching.

"I love the challenge," Jones said. "It's different than any other job because I have ties here. It's a chance to give back."

Jones could have chosen retirement, but instead he decided to coach one of the worst programs in Division 2 football.

The Rangers went 1-10 before Jones' arrival and repeated it under his first year at the helm.

Jones first year was not a Cinderella story. It was tough and a However, he said this year would be different because he finally has a chance to recruit his own players. Jones took the NWOSU job in December 2022 and arrived on campus in January 2023.

and signed a massive 40 high school players in the 2024 signing class.

He stressed recruiting is the absolute most important thing in college football. He said that if a coach cannot recruit then that coach could not be on Jones' staff.

He said his best recruiting job was hiring former NFL head coach Jerry Glanville as his defensive coordinator.

"He's one of the best defensive coaches of all time," Jones said. "His scheme is unlike any other that I've seen. [Glanville] told me I'm a great coach with a great defensive scheme already, but I had to tell him 'I know, but I need you to come coach for me."

Simpson named Northwestern's first All-American

On Tuesday Faith Simpson was named to the All-American First Team honors for the D2CCA.

With this she becomes the first Lady Rangers basketball player and also first Northwestern player to earn First Team All-American in the Division II era.

Since joining the Great American Conference in Division 2 NCAA football in 2011, the NWOSU Rangers have never had a winning season.

He did not have a chance to recruit his own players last year, but this year will be different.

"In changing a program, you have to bring football players we feel like we can win games with," Jones said. "I inherited good football players, but I just didn't have enough good football players."

Jones recruited 11 transfers

In addition, he wants to change the coach's mindset in recruiting players.

"In the past it was almost like we took players that we could get," Jones said.

Jones said he wants to stay away from the notion that NWO-SU has to recruit players that no one else recruited.

He said they could recruit with anybody in the state of Oklahoma.

Jones recruiting skills does not just stop with players.

Jones made his best sales pitch and with a little bit of encouragement he was able to sign Glanville as his defensive coordinator.

With Glanville at his side and a group of young ambitious coaches, this is the most excited Jones said he has ever been for a season.

Great American Conference players to earn All-American as Hannah Giddey from Southern Nazarene earned honorable mention All-American.


In her last season she earned All-Central Region Player of the Year, Central Region First Team, GAC Player of the Year and GAC All-Conference First Team.

Coach excited for next season

"I think this is going to be the best coaching staff I have ever worked with," Jones said. "I feel great with the coaching staff we have right now. ... I believe we are all on the same page on what we are trying to accomplish. We have one focus, and we're all here for the same reason, and that's to turn this program around."

Jones has been around elite coaches during his tenure in the NFL and Division 1 level, but he said this is going to be the best coaching staff that he has had. He said he is more connected with them since they are at a smaller school. He feels like he can understand them and get to know them more. He has a personal connection with them, and that is important to him.

While Jones stressed the importance of recruiting and his coaching staff, he said the players are the most important thing to the program. He wants to get closer with his players. He has them come into the office before their first class each day, so he knows that they are up and he can say hello to them.

While he is feeling affectionate for his players off the field, on the field he said he is as tough as nails.

"We set our standards higher as a football team and also in recruiting," Jones said.

Last week in one of the teams hard running days Jones told them that he was not going to compromise this year. Last year if they could not run down and back across the field, two times under 45 seconds then he would bump the time up to 50 seconds. This year, he is not budging.

"The players have to adjust, or they just won't play for us," Jones said.

Jones is not making the Rangers conditioning easy this season. He has increased the intensity of workouts and increased the number of times the Rangers are running this year. He wants all his athletes to be in shape this year.

Jones is currently 68 years old and has been coaching for 46 years. He has already coached and won at the highest level. He travels to and from Dallas when he can to see his wife who lives there. He could sit back, kick his legs up, retire and watch the sunset; but he will not.

"A season like what we just went through drives me because I'm not about to quit," Jones said. "When I finally walk away from this job, I promise the program will be in good shape. I'm not leaving till it is. This will be my last coaching job. ... When I walk, away people are going to be proud of this program and the success that we're having."

OPINION Royal rumors run rampant

This past month has been a wild time on the internet.

Kate Middleton, the Princess of Wales, has been the center of hundreds of conspiracy theories throughout the month of March. The public has been speculating where she is, as she has not been seen publicly since this past Christmas.

Due to harsh criticism and public pressure, Middleton released a photoshopped image that left the public even more confused. The speculation continued to grow about her whereabouts and the palace then followed with a video message from Middleton stating that she has cancer.

The public is still left with many questions and theories as to what the truth is. Many folks are worried about the safety and wellbeing of the princess.

What sparked these rumors and theories to start? Let's look back at the past few months and piece together what information has been given.

On Dec. 25, Middleton made her last public appearance for Christmas. Shortly after this announcement on Jan. 17, the palace announced to the public Middleton would be undergoing a planned abdominal surgery.

The announcement did not give any detail as to what the procedure was, just that it was planned.

Middleton returned home for the London Clinic on Jan. 29 and began her recovery process. There are no photos of her leaving the hospital, many assume this is for privacy reasons.

The end of February is when the conspiracy theories began.

Prince William pulled out of a



memorial service due to personal reasons, and the public assumed this was because Middleton was experiencing health issues. People began to worry about the princess, and the palace released another statement stating Middleton was doing well. However, this vague statement caused the public to speculate Middleton's whereabouts, as she had not been seen publicly in weeks. The rumors included botched surgery, divorce and even the death of Middleton.

On March 4 a paparazzi photo of Middleton and her mother was taken, but the image was poor quality and did not look like the princess, according to her followers. The image only fueled the rumor mill and caused the whole internet to begin worrying about the princess's wellbeing.

The height of the frenzy began on March 10, when Kate released a poorly photoshopped image for Mother's Day in the UK. The image had clear signs of photoshop or AI use, with her children's fingers being crossed and broken looking along with cut lines in the clothes.

The picture released was so poorly edited the Associated Press had to release a kill statement saying the photo was not real.

The rumors began to run wild online, with the public ultimately believing Prince William was cheating or somehow involved in covering up Middleton's death. I personally felt compelled to believe the conspiracy theories, as the photoshop was so shotty. I am confused on how such a highly regarded institution could have such a slip up.

Damage control began shortly after the photo was released, with Middleton stating she edited the photo herself. This was not believed by the public whatsoever, and only left people more confused.

The next major event to happen in this saga was on March 18 when William and Kate were spotted shopping. This however did not help the royals' case, as most people believed "Kate" was actually a body double.

The public would not get a sufficient answer until March 22, when Middleton released a video sharing that she has cancer.

In the video the princess thanks the public for their concern and states doctors found cancer while performing the planned surgery. She said she has been recovering privately and asked for time and respect while she re-covered.

While some people believed the statement, many people still believe the video was fake. Some accounts on X, formerly Twitter, have claimed the background moves at a weird angle, her facial expressions look unnatural, and the shirt she is wearing was also worn in 2016. The public began to worry about the validity of this statement and began to analyze the video.

I do believe most people think the palace is doing some shady things. Why would they release such a poorly photoshopped picture? Why was William not present in the video? Is the princess safe?

These are the questions I was left with after watching these events unfold. It is suspicious the way the palace handled the situation. I believe that Middleton has cancer, but the events leading up to the announcement make me suspicious. The rumors may have some truth to them, but the public will most likely never get the answers they are searching for.

The palace is known to have a checkered past, like their treatment of Princess Diana. People who supported Diana still believe Buckingham had something to do with her death.

However, there has been no concrete evidence to prove this rumor, so therefore, it remains a rumor. The public will most likely never know the secrets of the royal family so rumors and gossip are inevitable. I hope the princess recovers and is healthy, not only for her duties but also for her family. My main concern is the children in this situation.

I wish Middleton nothing but a speedy recovery.

Recently, Apple was hit with an antitrust lawsuit.

This has raised questions about whether Apple is running a monopoly as well as questions about ownership over digital goods. A lesser talked about part of this broader conversation is the Right to Repair.

The Right to Repair is an odd thing to talk about. It's basically what it says on the tin. It's the customer's right to repair a product they own. This is obvious for most things. You can put whatever parts you want on your car or in a computer.

But some companies have famously pushed very hard against this. The two most famous are Apple and John Deere.

John Deere was infamous for not allowing farmers to use third party products to repair their tractors and other vehicles. John Deere did this by using software lock.

Only John Deere approved technicians could unlock it. This practice led to an ongoing class action lawsuit over the Right to Repair. The allegation is that John Deere had a monopoly on the service tools their products needed. Apple went another route.

Apple products are designed to be hard to repair. One method is using non-standard screws on the phone. Another is to make the inner workings on the phone all one modular. This makes it hard to replace just one part. Iphone parts also react badly to being swapped in and out.

So, why do companies do this? Pro Right to Repair advocates might call them greedy and just wanting to control the consumer, but what reasons do these companies give for their practices?

One reason is that companies don't want to deal with third party parts. If a third party has malware or goes cataclysmic wrong, Lithium-ion batteries can explode and Apple doesn't want their brands associated with exploding phones.

It will do so with the company's brand all over it. Another reason is that companies don't want their designs to be poked around in. For instance, if your company had a special technology that made it take 50% less power, you wouldn't want competitors to reverse-engine your edge on the market.

As things stand now, Things are slowly going to the Pro Right to Repair side. States are passing the Right to Repair legislature. Last year, Joe Biden signed an executive order that was in the favor of the Right to Repair.

The lawsuit to John Deere was allowed to continue last year. Two years ago, Apple softened their stance with their Self Service Repair program.

The Anti Right to Repair side is, however, still lobbying and fighting against the Pro side. All in all, the Right to Repair is still being fought over and the fight doesn't seem to be ending soon.


Mr. Kaumans, I'm going to be going over what Easter means to us.

The NWOSU Esports Team is hosting their second summer camp for high schools.

The camp is sponsored by the Northwestern Computer Science program and Esports team and is funded by the Buckles and Tucker Endowments. The camp is open to all high school students entering grades 9-12 in the fall and will be from June 3-5th. This year on Sunday, March 11, Ramadan-the month of fasting for Muslims—began and will end on Monday, April 8.

Ramadan takes place during the time Muhammad recieved the first verses of the Quran in 610 CE (common era). Musliums believe the Quran is a holy book that cantains the revelation from God

Ramadan does not have a set date. Islamic calendar follows the literal cycles of the moon, and each month only begins when the new moon is sighted.

Ramadan starts when the new moon is sighted that month. Because they rely on the shifting of the moon, the date for Ramadan moves with the rotation.

The start day is different for everyone. The people rely on the moon to tell them when the start of Ramadan starts. The location of a person's changes when they can view the new moon thus moving the start date.

Each day of the fast, Muslims abstain from food, drink and sexual relations during daylight, eating before sunrise and after sunset.

Where did Ramadan begin?

Ramadan took place in the seventh century around 624 CE. It originated in the city of Medina located today in Saudi Arabia.

Does everyone fast for the full month?


The fasting that takes place during this month is required except for special circumstances.


